Re: MUDC Local Development Plan: Draft Plan Strategy – Public Consultation.

I write on behalf of Causeway Coast and Glens Borough Council and in response to correspondence dated 22nd February 2019, relating to the publication of your Local Development Plan (LDP) Draft Plan Strategy and associated documents.

DRAFT PLAN STRATEGY

Council comments on the policies and proposals contained within the Draft Plan Strategy are attached at Table 1, Appendix 1. In addition to these I wish to make the following comments:

Cross Boundary Sperrins Forum

The Sperrins AONB traverses our common boundary (as well as those of Derry City and Strabane and Fermanagh & Omagh District Council areas). The Sperrins Forum was set up in April 2017 primarily to ensure a high level of co-operation and communication among neighbouring councils as we prepare our Local Development Plans (LDPs). The Forum consists of both elected representatives and professional planning officers from the four relevant councils. It addresses the following common issues:

- Protection of landscapes and environmental assets through appropriate environmental designations;
- Management of Minerals Development;
- Improvement of road linkages and infrastructure;
- Sustainable tourism development; and
- Meeting peoples' needs.

Landscapes and Environmental Assets

Northern Ireland Regional Landscape Character Assessment (NIRLCA): Two of the eight regional LCAs located within MUDC traverse our common boundary:

- No.8 Sperrins
- No.15 Lower Bann Valley

Northern Ireland Landscape Character Assessment (NILCA) (NIEA, 2000): Five of the twenty-two local LCAs located within MUDC traverse our common boundary:

- No.29 Sperrin Mountains
- No.36 Binevenagh
- No.39 Glenshane Slopes
- No.51 Garvagh Farmland
- No.52 Lower Bann Valley

The Council notes the contents and findings of the landscape character assessment and review, and in particular, the intervening changes identified and action points arising in relation to No.39 & No.52 (above). It is noted, however, that the majority of both LCAs fall within MUDC boundary.

Minerals Development

The Council notes the designation and policy approach to managing minerals development in MUDC, including the following:

- Mineral Reserve Policy Areas (MRPAs);
- Areas of Constraint on Minerals Development (ACMDs); and
- Individual policies relating to hard rock and aggregates; valuable minerals and hydrocarbons; peat extraction; the restoration of mineral sites; and mines, shafts and adits.

DRAFT PLAN STRATEGY: SUSTAINABILITY APPRAISAL (INC SEA)

The Council notes the content and findings outlined in this environmental report and the detailed justification of how MUDC has arrived at the suite of policies and proposals contained within this Draft Plan Strategy.

ASSOCIATED REPORTS

The Council also notes the contents and findings outlined in the suite of reports and background papers that accompany this Draft Plan Strategy.

We looking forward to the continuation of our collaborative work as we progress our respective Plans.
