This representation is made by Wardell Armstrong on behalf of The Crown Estate, specifically in relation to Mid Ulster DC Local Development Plan 2030 Draft Plan Strategy published in February 2019 and in particular policies MIN 2 and MIN 3 of the Strategy.

Wardell Armstrong advises The Crown Estate in respect of its onshore mineral interests in the UK including Northern Ireland. The Crown Estate licences minerals in Northern Ireland which it is required to manage in accordance with its statutory obligations (see note below). As part of its management role, it awards commercial licences for the working of its minerals where the necessary permissions can be obtained.

The Crown Estate is an independent commercial real estate business created by The Crown Estate Act 1961. Under the 1961 Act, it is entrusted to manage its assets to deliver best value over the long term and return all its profit to HM Treasury. Over the last ten years it has returned over £2.4bn for the benefit of the public finances. As part of its portfolio, it awards commercial licences for the exploration and extraction of gold and silver deposits.

Having considered the policy position put forward by the Council, The Crown Estate is broadly supportive of the proposals and aims set out, subject to the following comments.

It is encouraging to note that the existence of high value metalliferous minerals, such as gold in the District is recognised and the potential economic benefits arising from exploration of these requires a separate policy response as set out in Policy MIN 3 – VALUABLE MINERALS AND HYDROCARBONS

We support the approach to ensure that exploitation of such valuable minerals resources is excluded from the policy presumption against mineral exploitation that otherwise applies within Areas of Constraint on Minerals Development (ACMD).

The Draft policy requires that proposals for exploitation of such resources to be considered against those policies contained within Policy MIN 2 – EXTRACTION AND PROCESSING OF HARD ROCK AND AGGREGATES a) to g).

The Draft Plan seeks to take into account the landscape importance of the AONB and consider the likely impacts of development on a case-by-case basis. Further emphasis would, in our opinion, be beneficial to the policy to recognise the need to balance these impacts against other positive effects, including environmental, social and economic benefits of working mineral within the AONB.
