Mid Ulster District Council makes the following Order in exercise of the powers conferred by Articles 10, 11, 13, 14 and 26 of the Road Traffic Regulation (Northern Ireland) Order 1997(1) and the Off-street Parking (Functions of District Councils) Act (Northern Ireland) 2015

The Council has consulted such persons as the Council considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the 1997 Order.

#### **PRELIMINARY**

#### Citation and commencement

1. This Order may be cited as The Off-Street Parking (Public Car Parks) Order (Mid Ulster District Council) 2025 and shall come into operation on the xxx day of xxxx 2025.

#### Interpretation

#### 2. In this Order—

"blue badge" means a badge of a form prescribed under section 14(1) of the Chronically Sick and Disabled Persons (Northern Ireland) Act 1978 (2) which is recognised pursuant to section 14A of the Act; "charging hours" means the period during which the driver is required to pay a parking charge for the use of a parking place specified in column 1 of Schedule 1 in accordance

"Council" for the purposes of this Order means Mid Ulster District Council

with the scale of charges set out in column 6 of Schedule 1;

"disabled person's vehicle" means a vehicle lawfully displaying a blue badge which has been issued pursuant to section 14 of the Chronically Sick and Disabled Persons (Northern Ireland) Act 1978 [1978 c. 53] or which is recognised within the meaning given by section 14A of the Act:

"driver" means the person who whether as owner or otherwise has the charge or control of a vehicle or being present is entitled to give orders to the person having charge or control thereof:

"electric vehicle" for the purposes of this Order means any vehicle which uses one or more electric motors for propulsion and falls within one of the following classes of vehicle, namely -

- (a) an electric car which is a vehicle constructed solely for the carriage of passengers and their effects, seating not more than 8 persons in addition to the driver;
- (b) an electric motor cycle which is a vehicle not being a motor car or electric car having fewer than 4 wheels and the weight of which unladen does not exceed 410 kgs
- (c)an electric light goods vehicle which is a vehicle, constructed or adapted for use for the carriage of goods, the permissible maximum weight of which does not exceed 3.5 tonnes.

"electric vehicle charging post" means apparatus which supplies electricity for the charging of electric vehicles;

"fee" includes any charge associated with the issuing of a licence and any such other charge or consideration that the Council deems appropriate;

"hand-held device" means apparatus used by a traffic attendant which is programmed to interface with the telephone parking system;

"intoxicating liquor" means spirits, wine, beer, cider and any fermented, distilled or spirituous liquor with an alcohol content exceeding 1.2 per cent by volume;

"light goods vehicle" means a motor vehicle, constructed or adapted for use for the carriage of goods, the permissible maximum weight of which does not exceed 3.5 tonnes;

"motor car" means a mechanically propelled vehicle constructed solely for the carriage of passengers and their effects, seating not more than 8 persons in addition to the driver;

"motor cycle" means a mechanically propelled vehicle not being an invalid carriage or motor car having fewer than 4 wheels and the weight of which unladen does not exceed 410 kgs;

"parking bay" means a space which is marked out in a parking place for the leaving of a vehicle of a type permitted by this Order, namely a motor car, a motor cycle, a light goods vehicle or an electric vehicle;

"parking charge" means any charge set by the Council for leaving a vehicle in a parking place authorised by this Order;

"parking place" means a place where vehicles of a specified class, may wait, subject to Schedule 1;

"parking ticket" means a ticket issued by a ticket machine relating to any parking place for which a charge is made identified in Schedule 1;

"registered driver" means the driver of a vehicle who has, prior to leaving their vehicle in a-parking place, had registered so many of their personal details with a service provider as that service provider may require to enable the telephone parking system to be activated in favour of said driver:

"service provider" means a person or company providing services to or on behalf of the Council;

"specified class" for the purposes of this Order means any vehicle falling into one of the following classes of vehicle, namely a motor car, a motor cycle, a light goods vehicle or an electric vehicle; only a vehicle which falls into a specified class of vehicle and which is listed in Column 2 of Schedule 1 is permitted to use the parking place listed in Schedule 1;

"specified hours" means the hours of operation which are specified in Column 4 of Schedule 1, pursuant to Article 3 for a parking place;

"telephone parking system" means a system to facilitate and monitor any parking charge paid using any telephone or internet enabled device via communication with the service provider in accordance with instructions indicated on signs located at each pay and display parking place where the system is operational;

"ticket machine" means an apparatus designed to issue a parking ticket indicating payment of a charge and the day and time at which it was issued and the number of hours for which it is valid or the date and time at which the ticket expires and which may include the vehicle registration mark of the vehicle the parking ticket was issued in relation to;

"trailer" means anything which is attached to, and is capable of, or intended to be, towed by, a vehicle; and

"vehicle" for the purposes of this Order includes any motor car, light goods vehicle, motor cycle or any electric vehicle of this type and, for the purposes of Article 5, includes anything which is attached to, or is protruding from, the vehicle.

#### **USE OF PARKING PLACES**

#### Specified parking places

- 3.—(1) Each area of land specified by name in column 1 of Schedule 1 may be used subject to the provisions of this Order as a parking place for such classes of vehicles during such hours on such days as are specified in relation to that area in Schedule 1.
- (2) The Council may close, on a permanent basis, a parking place, or any part of a parking place, specified in Schedule 1.
- (3) The Council may suspend, on a temporary basis, the use of a parking place, or a part of a parking place, specified in Schedule 1 where such suspension is for any reasonable use or purpose and in such circumstances as the Council considers reasonable.
- (4) Where the Council pursuant to paragraph (3) suspends, on a temporary basis, the use of a parking place, or a part of a parking place, specified in Schedule 1, the Council may do so for such period and on such terms as the Council may direct.

## Vehicles of a specified class

4. Where in Schedule 1 a parking place is described as available for vehicles of a specified class, the driver of a vehicle shall not permit it to wait in that parking place unless it is of the specified class.

#### Position in which a vehicle may wait

- 5.—(1) The driver of a vehicle shall not permit it to wait in a parking place other than in a position wholly within a parking bay where such has been marked out.
- (2) For the purposes of paragraph (1), anything which is attached to, or is protruding from, the vehicle must fit wholly within a parking bay where such has been marked out.
  - (3) A trailer may not wait in a parking place unless -
    - (a)it is attached to a vehicle of a specified class; and
    - (b)both the vehicle and the trailer occupy a position wholly within a single parking bay where such has been marked out.

#### Parking bays for disabled persons' vehicles

6. The driver of a vehicle, other than a disabled person's vehicle, shall not permit it to wait in a parking bay indicated by a surface marking or a sign as being reserved for a disabled person's vehicle.

# Parking bays for electric vehicles

- 7.—(1) The driver of a vehicle, other than an electric vehicle, shall not permit it to wait in a parking bay indicated by a surface marking or a sign as being reserved for an electric vehicle.
- (2)An electric vehicle waiting in a parking bay indicated by a surface marking or a sign as being reserved for an electric vehicle shall do so only if it is connected to an electric vehicle charging post and subject to paragraph (3).
- (3)An electric vehicle, which is fully charged, may be required to move from a parking bay indicated by a surface marking or a sign as being reserved for an electric vehicle.

(4) Use of an electric vehicle charging post, whether provided by Council or its service provider, may contain such terms and conditions that Council thinks fit, and may contain a condition requiring the driver of an electric vehicle, which is fully charged, to move that vehicle from the parking bay.

#### Maximum period for which a vehicle may wait

8. The driver of a vehicle shall not permit it to wait in a parking place for longer than the maximum period permitted for waiting specified in column 5 of Schedule 1 in relation to that parking place.

#### Use of parking place other than for parking

- 9.—(1) The use of part of a parking place specified in Schedule 1 for advertising may be authorised in accordance with a licence issued by the Council.
- (2) The use of part of a parking place specified in Schedule 1 for displaying information to the public may be authorised in accordance with a licence issued by the Council.
- (3) The use of part of a parking place specified in Schedule 1 for the collection of recyclable materials may be authorised in accordance with a licence issued by the Council.

#### Issue of licences

- 10.—(1) A person may apply to the Council for the issue of a licence authorising the use of part of a parking place specified in Schedule 1 for the collection of recyclable materials.
- (2) A person may apply to the Council for the issue of a licence authorising the use of part of a parking place specified in Schedule 1 for advertising.
- (3) A person may apply to the Council for the issue of a licence authorising the use of part of a parking place specified in Schedule 1 for displaying information to the public.
- (4) A licence issued by the Council may -
  - (a)contain such terms and conditions that the Council thinks fit;
  - (b)require payment of a fee, such fee to be determined by the Council; and
  - (c)be for such period that the Council thinks fit.
- (5)An application for a licence must be made in the form provided by the Council for that purpose and provide such information as is required by the Council.
- (6)The Council may require an applicant in any particular case to submit such additional information or documents as the Council deems necessary to determine the application.
- (7) On receipt of an application made under paragraph (1), (2) or (3) the Council, upon being satisfied that the use of part of the parking place referred to in that application for the purpose referred to in that application will not materially affect or materially interfere with the provision of parking spaces in that parking place, may issue a licence in accordance with Article 13(15) of the Road Traffic Regulation (Northern Ireland) Order 1997 authorising the use by the applicant of part of that parking place for that purpose.

#### Surrender and revocation of licences

- 11.—(1) A person to whom a licence is issued ("a licensee") may surrender a licence to the Council at any time.
- (2)The Council may serve on the licensee a notice revoking a licence, stating the reasons for the revocation if it appears to the Council that one of the events set out in paragraph (4) has occurred, and the revocation shall take effect on the expiration of the period of one month from the service of that notice.

- (3)A notice under paragraph (2) shall be served by delivering it to the licensee, leaving it at the licensee's proper address, or by sending it to the licensee by post.
- (4) The events referred to in paragraph (2) are—
  - (a) if the licensee fails to comply with any condition of the licence;
  - (b) if the Council considers the withdrawal of the licence is necessary for the purpose of the exercise of its statutory functions.

#### CHARGES AND TICKETS

#### Requirement to pay an appropriate parking charge

12. The driver of a vehicle using a parking place during charging hours shall pay the appropriate parking charge set out in Schedule 2 in accordance with the scale of charges specified in column 6 of Schedule 1 in relation to that parking place.

### Payment of charges

- 13.—(1) Save as provided for in Article 18 the driver of a vehicle leaving it in a parking place specified in column 1 of Schedule 1 during the days and hours specified in columns 3 and 4 in relation thereto shall pay the appropriate parking charge in accordance with the scale of parking charges specified in column 6 in relation thereto and set out in Schedule 2.
- (2) Where the following means of payment is available at a parking place, a parking charge may be paid by—
  - (a) inserting into a ticket machine a coin or combination of coins of appropriate denominations; or
  - (b) tapping or holding a payment card or device over the payment terminal of, or otherwise inserting a payment card into, a ticket machine and following the instructions displayed on the machine or;
  - (c) the purchase of a pre-paid charge card for use in a ticket machine; or
  - (d) the use of pre-paid tickets; or
  - (e) a registered driver using the telephone parking system; or
  - (f) use of direct debit.
- (3) The driver may, during the period for which a valid parking charge has been made, extend that period in accordance with paragraph (2) up to the maximum specified hours permitted in column 4 of Schedule 1.
- (4) Telephone and credit or debit card charges incurred in the course of making any parking payment transaction shall be the responsibility of the driver or person making the payment.
- (5) Where there is a requirement to provide a Vehicle Registration Mark connected to a means of payment for a charge under paragraph (2), the driver shall provide the Vehicle Registration Mark associated with the vehicle to which the charge relates.
- (6)Payment of an appropriate charge under paragraph (1) for a vehicle using a parking place .
  - (a) is not transferable to another vehicle; and
  - (b) is not transferable for use in another parking place.

#### **Pre-paid tickets**

14. In the case of pre-paid tickets the instructions given on the tickets in respect of making distinct perforations in the tickets or taking other appropriate action to clearly indicate the date and time of arrival shall be carried out by the driver as soon as he takes up position in the parking place.

#### Use of telephone parking system

- 15. If at any time a vehicle is left in a parking place during the specified hours, and no evidence of payment of a parking charge is otherwise visible, where a check is carried out by, or on behalf of, the Council and no indication that a parking charge has been paid using the telephone parking system in respect of that vehicle for that controlled parking zone appears on a traffic attendant's hand-held device it shall be presumed, unless the contrary is proved that either—
  - (i)a parking charge had not been paid in respect of that vehicle; or
  - (ii)the parking period for which payment was made had already expired.

## Display of printed tickets

- 16.—(1) The driver of a vehicle other than a motorcycle or electric motor cycle shall attach the ticket issued by a ticket machine or a pre-paid ticket duly perforated on the inside surface of the windscreen or on the front off side or front near side window or place the ticket on the dashboard area immediately below the windscreen so that the particulars recorded on the front of the ticket are clearly visible to a person standing at the front or side of the vehicle.
- (2) In the case of a motor cycle or an electric motor cycle, where a driver is required to pay a parking charge, the parking ticket issued by a ticket machine, or a pre-paid ticket duly perforated, shall be placed in a conspicuous position in a ticket holder or in front of the driver's seat.

#### Particulars of ticket

- 17.—(1) Where a vehicle is left parked in a parking place where charges may be collected by means of a ticket machine and the particulars on the ticket indicate that the period in respect of which payment was made has expired, for the purposes of any appeal under Articles 13, 16 or 28 of the Traffic Management (Northern Ireland) Order 2005 it shall be presumed, unless the contrary is proved, that said particulars are evidence of the expiry of such period.
- (2) Where a vehicle is left parked in a parking place where charges may be collected by means of a ticket machine, and a ticket is not displayed in accordance with the provisions of Articles 17 or 19(6) for the purposes of any appeal under Articles 13, 16 or 28 of the Traffic Management (Northern Ireland) Order 2005 it shall be presumed, unless the contrary is proved, that the absence of a ticket is evidence of the fact that a ticket has not been purchased.
- (3) Where a vehicle is parked in a parking place and the driver is required to provide a Vehicle Registration Mark connected to a means of payment for a parking charge under this Part for that vehicle, where the Vehicle Registration Mark of the vehicle parked in a parking place is not the same as the Vehicle Registration Mark entered for the purposes of charging, it shall be presumed, unless the contrary is proved, that the vehicle parked has not paid the appropriate charge.

#### **Season tickets**

18.—(1) The Council, or their service provider, may on application from the driver or owner of a vehicle sell to him a season ticket on payment of the appropriate parking charge referred to in Article 12.

- (2)A season ticket shall be valid only in respect of such parking places as are specified thereon for the period for which it is issued and for the vehicle in respect of which it is issued.
- (3)The Council may by notice in writing, served on the season ticket holder by recorded delivery post to the address stated on the season ticket holder's application, require the surrender of a season ticket where:
  - (a) the season ticket holder has not complied with the relevant Off-Street Parking Order; or
  - (b) a season ticket has been issued upon receipt of a cheque and the cheque is subsequently dishonoured; or
  - (c) the season ticket holder has ceased to have an interest in the vehicle in respect of which the season ticket was issued;

and the season ticket holder shall -

- (i) surrender any physical season ticket held by the driver or the owner to the Council, or their service provider, within forty-eight hours of the receipt of the said notice; and
- (ii) cease using the season ticket immediately upon receipt of the said notice.
- (4) The issue of a season ticket shall not guarantee that any parking place will be available for the use of the season ticket holder.
- (5)A season ticket shall include the following particulars:
  - (a) the registration mark of the vehicle in respect of which the season ticket has been issued;
  - (b) the period during which the season ticket shall remain valid; and
  - (c) the names of the parking places for which the season ticket is valid.
- (6)Where a vehicle in respect of which a physical season ticket has been issued is left parked in a parking place the driver shall display the physical season ticket in a conspicuous position behind the windscreen of that vehicle so as to be clearly visible to the parking attendant.

#### RESTRICTION ON USE OF VEHICLES AND PARKING PLACES

### Requirement to stop the engine of a vehicle

19. The driver of a vehicle using a parking place shall stop the engine as soon as the vehicle is in position in the parking place and shall not start the engine except when about to change the position of the vehicle in or to depart from the parking place.

#### Trading in a parking place

- 20.—(1) Subject to paragraph (2) and save as provided in Article 24 of the Road Traffic Regulation (Northern Ireland) Order 1997, a person shall not use a parking place in connection with the selling of any article or thing or supplying a service for gain or reward whether or not in, or from, a stationary position to persons in, or near, the parking place unless -
  - (a) the person holds a valid trading licence for the location issued by the Council under the Street Trading Act (Northern Ireland) 2001, and
  - (b) the Council has exercised its power under Article 3(3) to suspend the use of the parking place, or part of the parking place, for the location to which the licence at paragraph 1(a) relates; and
  - (c) the Council has given an express permission to the person to use the parking place.
- (2) Paragraph (1) shall not apply in respect of any fee payable for the use of an electric vehicle charging post.

#### Noise control

- 21. The driver of a vehicle using a parking place shall not:
  - (a) sound any horn or other similar instrument except when about to change the position of the vehicle in, or to depart from, the parking place or to warn of potential danger; or
  - (b) permit the playing of music, or create any other noise, which may cause annoyance to other users of the parking place or local residents or businesses.

#### Driving in a parking place

- 22.—(1) A person shall not, except with the permission of any person duly authorised by the Council, drive any vehicle in a parking place other than for the purpose of leaving that vehicle in the parking place in accordance with the provisions of this Order or for the purpose of departing from the parking place.
- (2) The Council may, where permission is sought by any person pursuant to paragraph 1, permit a part of a parking place to be used, whether once or from time to time, by any person for any reasonable use or purpose and the Council may do so for such period and on such terms as the Council may direct.

#### **Ball games**

23. A person shall not play any ball game in a parking place.

#### Miscellaneous activities

- 24. A person shall not use any part of a parking place or any vehicle left in a parking place—
  - (a) for sleeping or camping purposes;
  - (b) for eating or cooking purposes; or
  - (c) for the purposes of servicing or washing any vehicle or part thereof other than is reasonably necessary to enable that vehicle to depart from the parking place.

#### Means of passage

25. A person shall not use a parking place as a means of passage from one road to another road unless a right of way has been granted or express authority to do so has been given, in writing, by the Council.

#### Consumption of intoxicating liquor

26. Subject to Article 3(3), a person shall not use any of the parking places specified in Schedule 1, or any vehicle in any of those parking places, for the purpose of consuming intoxicating liquor.

#### Use of entrances and exits, and direction of travel

- 27. Where in a parking place signs are erected or surface markings are laid for the purpose of—
  - (a) indicating the entrance to or exit from the parking place; or
  - (b) indicating that a vehicle using the parking place shall proceed in a specified direction within the parking place,

a person shall not drive or cause or permit to be driven any vehicle—

- (i)so that it enters the parking place otherwise than by an entrance, or leaves the parking place otherwise than by an exit, so indicated; or
- (ii)in a direction other than that specified, as the case may be;

unless directed to do so by a Council employee, by someone acting on the Council's behalf, or by temporary signage erected by, or on behalf of, the Council.

#### Erection of structures and lighting of fires

- 28. In a parking place a person shall not—
  - (a) erect or cause or permit to be erected any tent, booth, stand, building or other structure without the written consent of the Council;
  - (b) light or cause to be lit any fire.

#### Supermarket trolleys

- 29.—(1) A person shall not cause or permit a supermarket trolley to enter a parking place in or under a building, and any supermarket trolley left there may be removed by a person authorised by the Council.
- (2) A person shall not cause or permit a supermarket trolley to be left in any other parking place, other than in an area set aside for that purpose, and any supermarket trolley so left may be removed by a person authorised by the Council.

# Reserving a parking bay

30. A person shall not reserve a parking bay in a parking place.

# Use of car park or sections of for the purposes of temporary meeting place

31. No persons shall use a parking place as a meeting place or point unless authorised by the Council in writing in advance.
